

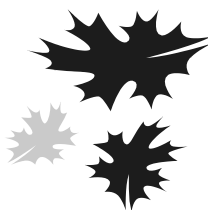

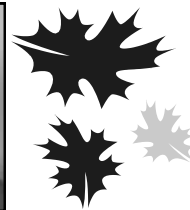

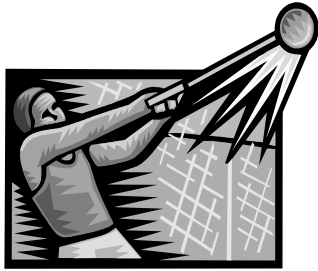

Smashing Barriers to Equity in Education: 2012 State Convention Theme

You might drive west over the mountains or you could cruise the I-5 corridor. But when was the last time your destination was Tacoma—downtown Tacoma, at that? If you haven't been there lately, you're in for a pleasant surprise.

Mark your calendar to save April 13-15, 2012 for ***Smashing Barriers to Equity in Education***, the biennial AAUW-Washington convention. We are thrilled to be meeting at the University of Washington-Tacoma, our newest AAUW College-University member institution. Here's an overview of the activities.

Friday— Take time to explore three close-by museums: Tacoma Art Museum, The Glass Museum and the Washington State History Museum. Docent-led tours will be available. The afternoon will be free for a late lunch or early supper at one of the many fine restaurants and eclectic cafés within walking distance. UW—Tacoma faculty will join us at a reception in the early evening.

Saturday—Our annual business meeting and elections will be held. There'll be workshops, a panel discussion on access to higher education, speakers from AAUW headquarters, and presentations to give you tools to aid your branch in getting out the vote for 2012. The busy day is followed by our evening banquet.

Sunday— Election results will be announced and any remaining business concluded. Following the business session, there will be a panel discussion of AAUW's latest research report, *Crossing the Line*, which presents new data on sexual harassment in schools.

We'll be meeting at UW-Tacoma so there's no convention hotel. We'll have suggestions for nearby accommodations closer to the date. Plan to be there!

The Search Is On!

Each of us has a job to do. At AAUW-Washington, we need to find qualified candidates for the offices of state president, membership vice president and finance vice president. Please look around your district. Who is leading/has led branches there? Who has the experience, energy and vision to lead all of us in the state?

You may contact your district's representative on the nominating committee or you may contact the chair of the committee directly. Our bylaws state that nominations shall be done four months prior to our state convention to be held on April 13-15. Now is the time to find our candidates!

You may nominate yourself or another member, anywhere in the state. Candidates may serve no more than two successive terms.

The office of president requires a previous term as a member of the state board. [Branch presidents are members of the state board.] The term on the board does not have to be the current term.

We have had successful experience with co-officers and can consider that possibility again. It is very acceptable to nominate yourself as well as search for others in the state. Feel free to contact present or previous holders of the office if you need a "feeling" for what is required. The nominee must agree to be a candidate. Klaras will be happy to deal with that part of the process!

Lynn Dissinger recently joined the Seattle branch where she serves as public policy chair.



Though new to the branch, she is not a “newbie” to AAUW or to public policy. Active in AAUW for many

years, she was state legislative chair and program vice president in Pennsylvania.

She moved from Pennsylvania to the Pacific Northwest in 1993 and joined the Renton branch, serving in a number of branch roles, including president. After taking a few years off to focus on her career and other business organizations, she is back in AAUW and looking forward to reconnecting to the work that we do.

Tracy Sherman recently moved back home to the Pacific Northwest after spending almost a decade in the other Washington. She now works as a policy analyst at the League of Education Voters where she advocates for a variety of education issues including early learning education and improving school discipline policies.

Special Projects Fund Now Available for Branch Activities

Does your branch dream of doing a project that promotes education and equity and supports the AAUW mission? Is your branch currently working on a project but needing a way to get tax-deductible donations? Does your branch need more financial resources to take its project to the next level or expand it?

Maybe the Washington State AAUW Special Projects Fund can help!

The AAUW-Washington Special Projects Fund (SPF) is a tax-exempt corporation under federal and Washington State rules. The fund was established to receive and distribute tax-deductible corporate and individual donations for AAUW-approved projects within the state of Washington that further education and equity for all women and girls. SPF is a pass-through fund; approved projects secure their own funding.

One project, the High School Expanding Your Horizons conference at Bellevue College, has already qualified to use the SPF. It is in the process of applying for donations of software, computer equipment, and other items, as well as cash gifts to support the conference.

Branch leaders for projects such as Expanding Your Horizons, \$tart \$mart and other mission-based activities are encouraged to investigate how the SPF can be used to make that project happen. Send an email to specproj@aauw-wa.org to get more information and an application form.

There are several mailings and programs of which everyone should be aware. They can help you recruit, renew and retain your membership throughout the year. Did you know about . . . ?

Membership Kits from National – If your branch has not received the Annual Starter Kit or Market Your Branch Tool Kit from National, please let us know. The kit(s) may not have been sent because either the branch membership vice president or branch president/administrator was not registered with the national office. It has brochures, membership program details and other helpful information.

“Shape the Future” Membership Campaign – Have you taken advantage of this? Both Issaquah and Clallam Branches have taken advantage of this campaign. “Shape the Future” Membership Campaign is a program used to help branches recruit new members by offering half-price national membership rates for new or lapsed members (two or more years) to join on the spot during AAUW-sponsored activities. Branches build their member base and earn up to three free memberships annually to use any way they wish. When entering information on the Additional Dues Remittance form (ADR), choose code “STF”. 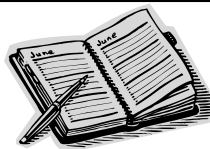
